

Dear group leader of school and youth groups,

Viking Line aims for all our passengers to enjoy their stay on board and our staff will always work to attain the goal of a safe environment. We kindly ask you to inform your group about the regulations below and to ensure that they are followed:

- I. A group participant who has consumed alcohol or has brought alcohol in their luggage will be rejected at the port of departure or at any other port during the trip.
- 2. The ships are governed under the legislation of Finland. A person under the age of 18 is not allowed to buy alcohol on board. If any minor has alcohol in his/her possession, the ship's crew is entitled to confiscate the alcohol.
- 3. The security staff has the right to detain passengers under the age of 18 who are under the influence of alcohol or who have caused disorder on board.
- 4. Your fellow passengers keep the right to a quiet and restful environment in the cabin area. People who disturb other passengers in the cabins or in the cabin corridors, may be removed from the cabin area by the crew. People who have caused disturbance may also lose the right to their cabin.
- 5. Any intentionally caused damage to property on board must be compensated for. The compensation does not immediately take place on board, the ship will file a police report. The group leader will be required to act as a contact person during the investigation of the claim.
- 6. Shoplifting and theft will always be reported to the police and to guardian of the minor.
- 7. All passengers are required to be able to prove their identity with a valid ID documents.
- 8. The group leader is required to travel in the same cabin category as the rest of the group.
- 9. A name list with cabin numbers must be submitted to the ship information desk at the time of boarding.
- 10. The group leader must sign this agreement before boarding the ship.

We kindly ask you to board as a group, under supervision of the group leader.

We believe that through mutual cooperation both youth groups and fellow passengers will enjoy the voyage.
